6. **Damage to Buggy (Not Applicable for Beginner Golfers less than 14 years old)**

S\$ 1,000

Extended to cover accidental loss of or damage to NSRCC's/KSGC's buggies whilst being used by Beginner Golfers at the NSRCC's/KSGC's golf course or at driving range. Cover is extended to Beginner Golfers who are 14 years old and above and with a minimum height of 1.4 metres. Beginner Golfers must have the written consent of their parent before the Beginner Golfer is allowed to drive or use the buggies on the golf course.

Total sum payable to any one Beginner Golfer shall not exceed S\$1,000 in the aggregate. Excess: S\$200 each & every claim.
