TERMS & CONDITIONS

- Any person who is serving or have completed full-time national service and is rendering operationally-ready national service may apply to be an Ordinary Member.
- Any person who has completed full-time national service or has rendered operationally-ready national service may apply to be an Associate Member.
- Full Membership shall enjoy full access to the Club's golfing and social facilities at any time of the week. Basic Membership is limited to weekday golf only (public holiday excluded) but shall have full access to all social facilities at any time.
- Subject to Paragraphs 1, 2, 3 and 7 herein, the Membership may be for a term of [^]2, 5 or 10 years.
- Upon each Membership term expiry, a member will have the option to renew his Membership subject to *eligibility, payment of prevailing entrance fee or any other fee as determined by the Club, provided that the aggregate of the total membership term shall not be more than 30 years for Full Membership. Basic Membership shall not be subjected to a maximum of 30 years, but shall be as long as may be stipulated by the Club in their absolute discretion.
- An Ordinary/Associate Member may apply Family Membership for his spouse and children between 5 to 21 years of age, who may use the Club's facilities subject to the provisions of the Club Constitution and Bye Laws as well as the type of Membership. The monthly subscription fee and any other fees payable shall be determined by the Club.
- The Ordinary/Associate Member is responsible for the conduct of or any debt or liability by his spouse, children and guests.
- There shall be no refund of any entrance fees or part thereof already paid to the Club upon the confirmation of a current and/or an extension to the current Membership term.
- An Ordinary/Associate Member may terminate his Membership at any time by giving notice in writing but shall continue to be liable for any subscription fee or other debts due and unpaid at the date of cessation of his Membership. There would be no refund of any of the Membership entrance fee.
- All Members, nominees under the Family Membership as well as guests sign-in by the Members are subject to the provisions of the Constitution, Rules, Regulations and Bye-laws of the Club.
- The Club reserves the right to reject any application without assigning any reason whatsoever and to amend the Terms & Conditions without prior notice.
- In the event the Club ceases to be the lessee of all of the land on which the Club premises are situated or such substantial part thereof as would render it impracticable to continue to provide golfing, social, sporting and other recreational activities for the membership, all Memberships shall be terminated on the date of the Club's dissolution. The Club shall be discharged from all liabilities and obligations to the Members, whether set out in the Club's Constitution or elsewhere. No Member shall have any claim against the Club except in respect of monies standing to the credit of the Member in the Club's account. Members shall remain liable for all unpaid dues, debt and other liabilities incurred as at the date of dissolution.
